

## OH & S Report

#### By Steve Clift

The motor racing season is now well on the way. It is therefore appropriate to remind you that everyone has a role to play in making our track side experience as safe as possible.

We are aware that there are some issues, in particular at Mallala, that have been raised previously, that perhaps have not been dealt with as yet. Even so, whilst participating as officials, we MUST always be on the lookout for hazards that may be of a danger to participants or officials, no matter how minor they may seem.

We all have a DUTY OF CARE to inform other members of our team and to report these issues to the T&CC, using the Performance Sheets at the end of the day. Refer these hazards to your Senior, and in some cases, they may need to be referred to Race Control immediately.

If you are the Senior at a point and are aware of a hazard, include details in you briefing and also, what action needs to be taken during the day, to avoid an incident.

It would also be appropriate to inform the Chief Flag for the day, of any issues of concern.

If these issues remain outstanding the next time you are in that zone, don't hesitate to raise the issue again.

If you are unsure what to do at anytime, refer immediately to your Senior and/or Chief Flag.

By referring these hazards, we are completing our obligation as an Association and exercising a DUTY OF CARE.

# T & CC Report

You haven't heard from the T&CC since November and for that I apologise! I missed the deadline for the Newsletter, not once but twice! Well, whilst I missed the December issue, <u>both</u> the Committees missed the January one so it looks like I'm in pretty good company hey??

The one thing I really did want to say in my December article was a huge thankyou to each and every one of you who comes out week after week to support motorsport in SA. 2012 was a fairly tough year when it came to filling those concrete bunkers at Mallala, well we did it and the best part was that even though we were down on numbers, we did it safely and going by the comments we received, we know <u>ALL</u> the drivers and teams greatly appreciate our commitment and professionalism at each event.

Now what can I pass onto you for this year: Firstly, for those who are not aware, we have finalised the positions for this year's T&CC:

Chairman is Paul Bonnett and Secretary is Steve Clift. (Steve will be backed up by one of the committee if he is unable to make a meeting) The remainder of the Committee is: Bradley Morrison, Matthew Johnson, Tony Aloi, Rod Mountifield and Dieter Von Zieden. The Chief Flags and CoC's have been allocated to the first three events for the year and these events are also loaded on the Database:

Feb 10 – Superkart / Modern Regularity, (CF is Loui Mori) and

**Feb 16** – SA State Circuit Racing Championship – Rnd 1 (Twilight) CF for this one will be Peter Cirillo and Assistant is Ray McGuiness.

Then of course: The Clipsal 500 – 28 Feb to 03March.

Mar 30/31 – Easter National Historics (CF for this one will be Paul Hart and IF we get the numbers we may allocate an Assistant)

As Paul H. mentioned in his report, Clem Smith (Mallala Motorsport Park) and the Sporting Car Club have entered into an agreement that both parties will be responsible for organising and promoting the State Championship Rounds and the Easter Historics for 2013. This has resulted into some changes that will affect us as Officials:

1. We have put a limit of 38 names on SAMROA's gatelist and unfortunately if there are any more we will not be able to accept you,

The gatelist will now close off 10 DAYS before the event and there will be NO EXCEPTIONS, we cannot "slot" you in at the bottom of the list as we could do in the past. If your name is not on that list and you turn up on the day of the event you will have to pay to enter the track. The Chief Flag will be contacted and if we are below the 38 officials you will be reimbursed your entry cost by the SCC; if we are over 38 then you can enjoy the day as a spectator – you will not be able to go trackside!

This above procedure will be for the State Rounds and Easter Historics, it should be the same for the Shannons but we are unsure if you will be reimbursed as this is Clem's event – not the Sporting Car Club's

2. Guest passes will no longer be made available for family and friends – ALL will now have to pay to enter the venue.

These are the main changes at this time but whether we agree or disagree, we have to adhere to these requirements. Please ensure you get your names on the gatelist early, (Red Book, Database or contact one of the Committee Members) that way you will be assured of a free entry on the day – we can always take your name off the list if you can no longer make it.

And just to confirm, these changes are for the traditional SCC events, there are no changes to the requirements for the Superkart / Modern Regularity events – we will continue to take victims (sorry volunteers) up to the day.

As you may well know, we have been trying to organise a fire training day but due to the commitments of both SAMROA and the Women for Wheels, this has not occurred. At this time, we cannot promise that it will happen but as we discussed at our last meeting, <u>IF</u> we can organise a time and place we MAY be able to run both Fire Fighting and First Aid courses. Be aware though that the priority for this year must be the First Aid Course. This is because the members who did the last one back two years ago will need to be re-certified. We will aim for mid to late 2013 for the training (Before November) so stay tuned for further information.

The SAMROA equipment bags need a bit of maintenance / replacement as a few of the zips have broken, we will get these replaced hopefully soon and if we can find a suitable donating company, we will replace the gear in them also (Gloves / vests / first aid kits) – if any of you know of a company we can approach, let us know.

Just before I close, I would just like to remind you all that the T&CC is here for the benefit of all SAMROA members, if any of you have a "gripe" with what occurs then put it in writing and be brave enough to put your name to it – if the criticism is genuine then it will be actioned on but we will not pay any attention to rumours or fact-less gossip. It has always been our policy to try and

give you guys new positions to work at, please realise that this can only happen if the attendance numbers pick up at events – we know it's a "catch-22" situation but sometimes our hands are tied – we've said it before, "If you wish to try something new – let us know and we'll try to accommodate it.
